# Location

QTSC is located in Ho Chi Minh City (HCMC) - the largest economic center in Vietnam.

- 15 minutes from QTSC to the Tan Son Nhat international Airport
- 45 minutes from QTSC to downtown.



# Incentives

Organizations and enterprises performing new investment projects in QTSC will be enjoyed the following supports:



- To be entitled to select form of land assignment with collection of land levies, renting ground or subleasing land which has been built the infrastructure as prescribed by law;
- To be applied the tax rates of enterprise income tax of 10% for 15 years, exempted tax 04 year, reduced 50% of the payable tax for 09 next years for enterprise incomes from implementation of new investment projects at the concentrated information technology park. For enterprises established newly from investment projects in the information technology field with big scale, and need special investment attraction, duration applied the preferential tax rates may be prolonged but total duration applied tax rate of 10% does not exceed 30 years. The Prime Minister shall decide the expansion of duration applied the preferential tax rate of 10% as prescribed at this Clause at request of Minister of Finance;

To be exempted import tax for goods imported to create fixed assets and serve for production of information technology products and services of enterprises, including:

Equipment and machinery;

• The special-use means of transport in the technological chain that cannot be produced domestically; means of transport for workers including automobiles of 24 seats or more, and means of waterway transport;

• Components, details, separate parts, spare parts, fittings, molds and accessories enclosed to assemble synchronously with special-use equipment, machinery, and means of transport specified at point a and point b this Clause;

• Raw materials, supplies that cannot be produced domestically, used for manufacture of equipment, machinery placed in technological chains or for manufacture of components, details, separate parts, spare parts, fittings, molds and accessories enclosed to assemble synchronously with equipment, machinery specified at point a of this Clause;

- Construction supplies that cannot be produced domestically.
- To be enjoyed preferences of export tax for information technology products and services as prescribed by law;
- To be facilitated for customs procedures in course of export and import of machinery, equipment and information technology products and services;
- To be enjoyed preferences on investment credit and export credit of State, the national fund for science and technology development and other credit institutions as prescribed by law;
- To be enjoyed other incentive policies of State applicable to enterprises operating in the hi-tech parks. If an enterprise is subject to be enjoyed many preferential levels as prescribed by law, it will be applied the highest preferential level.

QTSC welcomes all social and economic organizations, individuals living in Vietnam as well as from abroad to invest in the fields of:

• Construction and business of technical infrastructural works; Research – development, application and transfer of information technology; production and business of software products, digital contents, and information technology services; production and business of hardware products, electronic products in the hi-tech list prioritized for development investment and list of hi-tech products encouraged development as prescribed by legislation on high technology; training human force in information technology; technology incubation and information technology enterprise incubation; commercial promotion, investment promotion in information technology; provision of services for activities in the concentrated information technology parks.

# INVESTING And DOING BUSINESS IN QTSC ?

QTSC is the first centralized information technology (IT) park in Vietnam to offering one-stop service. At the park, enterprises can take advantage services free of charge that QTSC has been providing for enterprises such as establishing companies, business and investment licenses, import-export services, transferring or leasing lands, construction licenses, immigration visas, visa extensions, work permits and legal matters.

# A. Registration of investment project

#### Documents

- Application for the implementation of investment project;
- Proposal for the investment project;
- Report on the financial capacity of the Investor;
- Explanation on the satisfaction of business conditions;
- Legalized copy of the Business Registration Certificate and Charter of the Investor;
- Legalized copy of the Audited financial statements of the Investor (2 newest years);
- Legalized copy of the passport of the authorized representative of the investor;
- MOUs on the lease of the premises of the Company.
- Duration of licensing: Within 15 working days from the date of full receipt of the valid dossier.
- Implementation Result: Investment Registration Certificate.
- Investment registration fee: None.

# Business Registration

### Documents

B

- Application for enterprise registration;
- List of members/ founding shareholders;
- Charter;
- Valid copies of the following documents:
- Citizen identification card or ID card or valid passport (if the founder is an individual);
- Establishment decision or enterprise registration certificate or other equivalent document (if the founder is an organization); ID card or valid passport of the authorized representative and the corresponding authorization letter.
- Duration of licensing: Within 03 working days from the date of full receipt of the valid dossier.
- Implementation Result: Enterprise Registration Certificate.
- Business Registration Fee: 200.000 VND.

**Note:** If you have not got your business license yet, please make your reference to part B

- Sign in contract for re-leasing land with QTSC then QTSC will hand over the real land to investor;
- QTSC will guide and support you to get the construction license and "right of land used" certification;
- QTSC will instruct investor all steps for constructing;
- Invertors commits to use the service under the contracts such as contract for providing geology drill, infrastructure service and hygiene environment.
